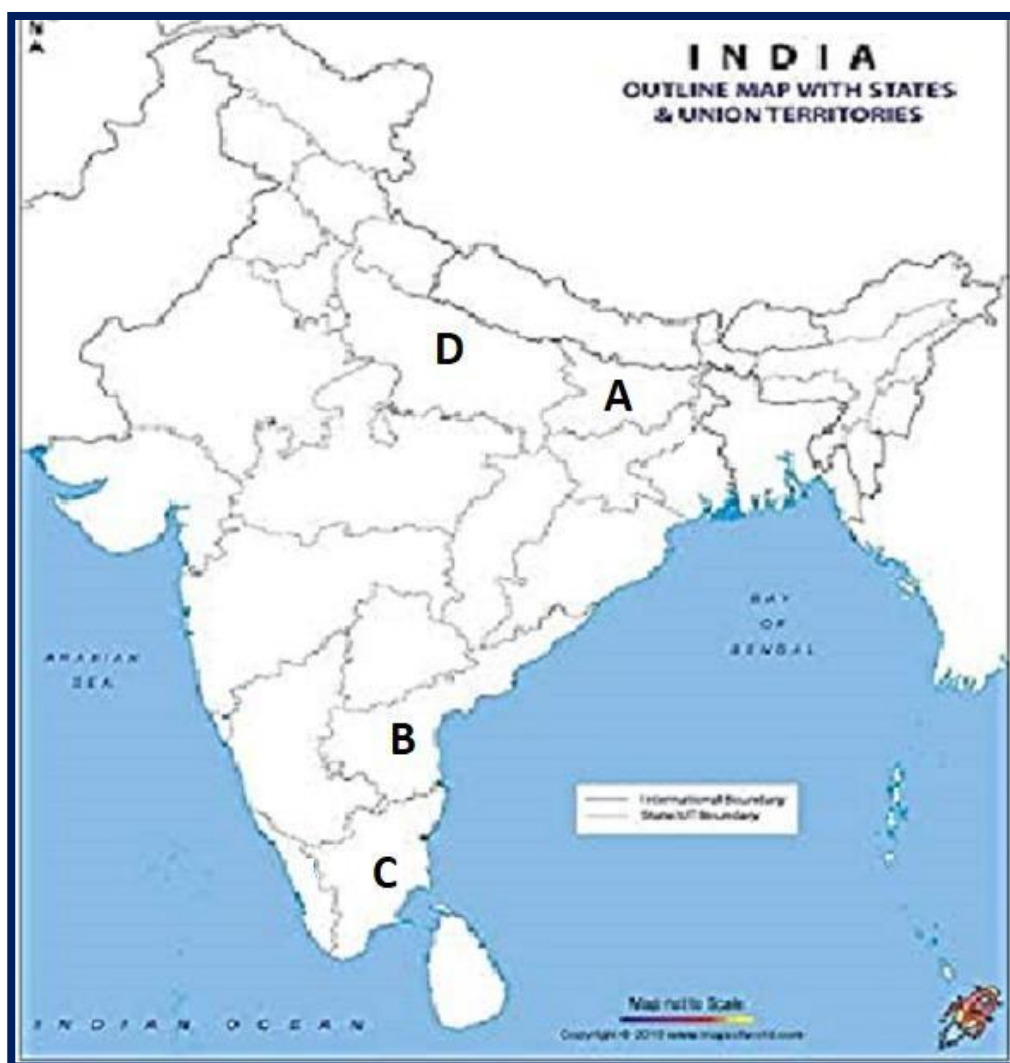

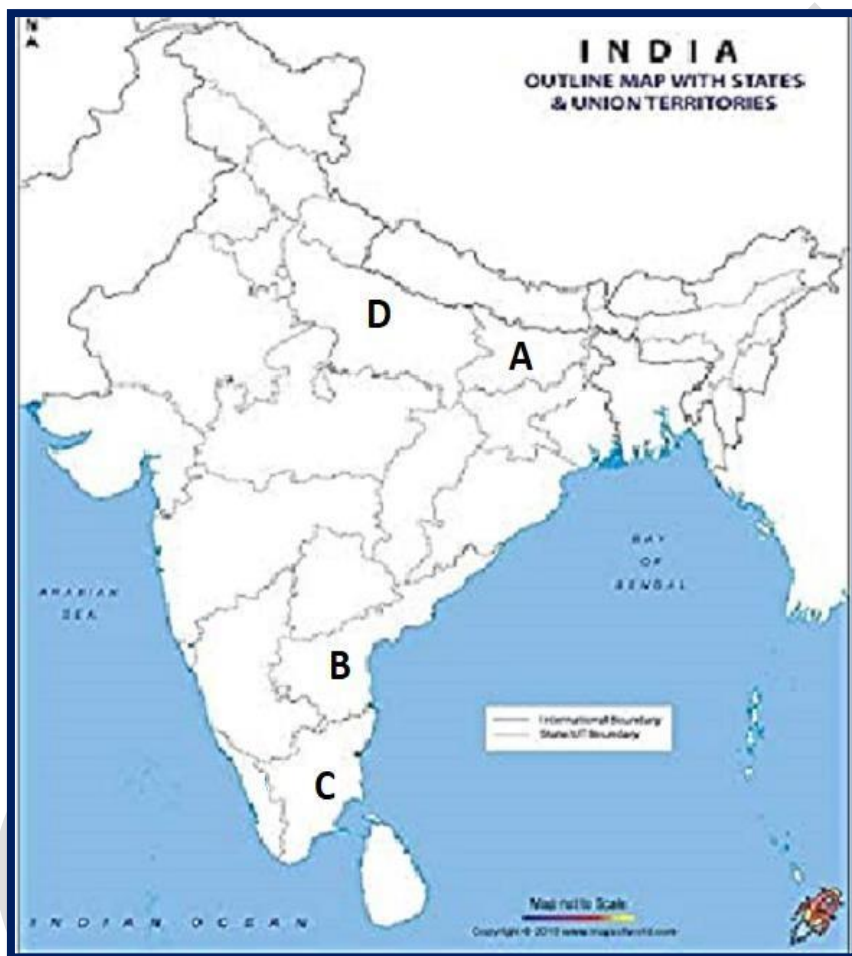

Nehru had always put his faith in science and technology for rapidly building a modern India. A significant component of his industrialization plan was the nuclear program initiated in the late 1940s under the guidance of Homi J. Bhabha. India wanted to generate atomic energy for peaceful purposes. 2. India advocates no first use and reiterates India's commitment to global verifiable on non-discriminatory nuclear disarmament leading to a nuclear weapon free world. 3. India was against nuclear weapons, hence pleaded for nuclear disarmament with superpowers. 4. India always considered NPT as discriminatory and refused to sign on it. 5. Power began to shift from the Soviet centre to the republics, especially in the more Europeanized part of the Soviet Union, which saw them as Sovereign states.</p> <p>3. The administration and political system of the Soviet Union became stagnant. The Communist Party that ruled the Soviet Union for over 70 years was not accountable to the people. Rampant corruption, unwillingness to allow more openness in government led to the collapse of the system.</p> <p>4. Gorbachev's ignorance and his liberal outlook, in turn, strengthened the anti-communal forces in Eastern Europe. Consequently, Czechoslovakia, Romania, Hungary, Poland, Bulgaria and East Germany witnessed the downfall of the communist regimes. The best way to respond to regional aspirations is through democratic negotiations 3.
