1. (a) Examine how role models influence ethical behaviour. What actions can leaders take to integrate ethical conduct in their organisations? 10

Role models have great influence in changing behaviour of the organization. They provide a symbol whom staff looks up and imitate in their day to day life.

A hardworking, sincere and honest role model brings positive change in organizations than someone who is always late and keeps his work place untidy.

Example can be taken of E. Sreedharan who with his personal values and integrity had great influence on entire DMRC organization. He was always punctual and honest in duty. Because of this it is now known Delhi Metro has

99% of punctuality. His ethics of being punctual percolated into entire organization.

### Actions to integrate ethics and organization


- They should be inspiration through their leadership and their conduct.
- Code of ethics with all stake holders is positive role
- Citizen charter with all stake holders involved.
- Developing capabilities and skills to deal with ethical issues
- Transparency and impartiality
- Bringing positive work cultural changes

All these changes mainly aim at bringing attitudinal changes which are long lasting. Leadership should aim at behavioural-attitudinal changes for greater impact.

Aristotle says persuasion has three components.



This is because the emotional connect will create a long lasting impression and success of persuasion. This shows that speaker respects their cultural and emotions.

Example can be given here of recent accidents in Karnataka. where villages were not willing to construct toilets in their backyard even after brushing the government officials and their knowledge on this cause.

This is because government officials failed to connect to the people's emotions and cultures which calls for prayer of Nagadevata in the backyard. So their persuasion is not fruitful.

For any persuasion to have long impression it need to have emotional connect. This allows retention of idea in mind of people. This emotions bring change in attitude of people.

The emotion it connects with cognitive and belief systems. The logic and knowledge can be argued but emotional connect is needed.

This can be seen in all our river cleaning programs, where people could not have emotional connect and so failure of programs.

2. (a) With appropriate examples, discuss various ethical challenges associated with the utilization of public funds in India. Suggest strategies to effectively deal with these challenges. 10

With increase in globalization and nature of public sector and changing roles of civil servant, there have been certain ethical challenges associated with utilizing public funds in India. Some examples are.

Land acquisition from tribals and farmers for industrial corridors and mining. The rules says to pay compensation and rehabilitate them but personal ethics says that their culture and natural connect with forest is lost. This poses ethical challenge in delivery of services.

The programs where discretionary powers to be used also pose ethical challenges. The use of technology for public works might be against some personal values of keeping distance

to technology in people relationships. This pose challenges to civil servants.

Corruption and leakages of funds have become major challenge, so this calls for whether to allocate more funds or reduce flow to these policies to reduce corruption.

The ethical challenges are mainly due to.

- Difference in personal and professional ethics
- Multiple justifications
- Superiors and system guidelines, orders.
- Code of ethics.
- Multiple accountability.

Strategies to deal

• One should have his conscience of this challenges and deal with it and not hide.

- Use of technology.
- Capability and skill building
- Transparency and reducing corruption

These ethical challenges have to be addressed for having better service delivery.

Social media has brought significant change in people's attitude and also government functioning. But there are issues of its freedom and regulation and what can be real boundaries. In this context.


(a) The effect on social and political culture.

### (b) Role of social media on youth attitude.





- The code of conduct / ethics
- Employee aspirations, needs, skills to be improved
- Conflicts of interest should be reduced.
- Development of groupings / faction for negative purpose
- Understanding the real essence of work.
- Participatory nature should be improved.
- Behavioural and attitudinal change.

The employees should be made to understand the real essence and meaning of work and bring attitudinal and behavioural changes for lasting work culture.

3. (b) There is a difference between what a person has a right to do and what the right thing to do is and often there is a conflict between these two. (a) Illustrate with examples the ethical issues that can arise because of such a conflict. (b) How does this conflict play out if someone wants to protest against injustice? 10

In day to day life as well as organization one come across several ethical dilemmas including what a person has right to do and what is right thing. These pose conflict between two.


(a) I take example of our Independence / freedom struggle where there were restriction on protest and publishing the views. There were no rights of freedom of expression. But the truth and injustice has to be told - This is the right thing to do.

A true follower of rules would face struggle about how to face this challenge and conflict. This poses ethical issues - of should one follow

rules and get exploited or should one question the rules.

(b) Our national leaders have choose to follow what ought to be done. Not because law exists, they believed in natural law of justice.

They had protested against justice, since the law was immoral they had no guilt and trouble, but in case where law or rules are against ones morals, that might lead to guilt.



thus one can see when one does what ought to be there is satisfaction. But otherwise guilt. So one should exercise to occasions and follow what ought to do.

The individual is member of society.


The individuals interests get reflected in the interests of society. So in order to have benefits one has to address interest of individuals.

The interests of people of software hub and locality want greater protection and safety in job and society. The changing trends have to be respected. Community have to move away from traditional setup and conservative

mindset and fulfill interests of soci. individual  
The conflict between these two could lead to  
problems of violence on Jan 1, in Bangalore.  
There should be greater overlap of ones beliefs  
and value system with community.



There is also need to protect individuality  
of the people. This in essence means growth  
of diversity as well as coherence with community.

The actions are manifestations of vision and intention. These have to be sight for better results. But these play important in political ethics. The implementation part also is important.


For example:

Many developmental programs in India were launched with aim to establish growth and reduce poverty. PDS system, MGNREGS etc... were meant to provide employment and reduce poverty.

But poor implementation; corruption and leakages had made it fail in reaching real vision.

The implementation is a part of social justice and the political system need to

have strong ethics in order to reduce the deviations from ethics intents.



The recent controversy of use of Aadhar also fall under this setup. The intentions of the government are noble to direct delivery services but implementing tools of policy issues are questionable (the issue with so to decide now).

Thus it can be seen that in political ethics not just intention but also implementation is important. One needs to grow the capacity of implementation agencies for better results.

5. (a) Swami Vivekanand brought religion to the centre-stage and gave a new meaning to it while stressing the need for harmony among faiths. In this context, discuss the relevance of his teachings in contemporary society. 10

Even after 100 year his philosophy still holds relevance in contemporary India. This is because.

- Increase in mistrust among people, - religious,
- Lack of understanding of real meaning and nature of religion.
- Increase in material aspect.
- Intolerance
- Weakening of morals and value system.

## Relevance in contemporary India.

we can take inspiration from his idea of welfare of all. one should collectively fight against poverty and corruption. All religions he says aims for human untegration and harmony.

His idea of harmony between materialism and spirituality helps to overcome the reduced values and morals. The idea of spirituality and religious harmony helps to fight against radicalization.

He calls for peacefull living of all cultures and ultimate aim as betterment of all, one has to liberate and do good.

His ideas of religious harmony thus hold even true today, One has to take best of this and work against poverty.

5. (b) Access to quality basic services plays a critical role in enhancing individual capabilities to participate fully in the growth of the nation. (a) Discuss the statement in the context of vulnerable sections of India. (b) Analyse the challenges with regard to quality service delivery in India.10

Man by virtue has some natural rights, and access to basic services are aimed at fulfilling those rights. The programs of Food security, MGNREGS etc were aimed at providing enough work and food so that he can fully participate in growth.

(a) Vulnerable section of society have traditionally deprived of these natural rights and were not provided access to education, occupation etc..

The basic services like Sarva Shiksha Abhiyan etc... were meant to bring them to level playing field with other candidates.

The reservation and health facilities were meant to build capacities and make them part of society.

(b) There are certain challenges in this regard. They are.

- Insensitivity of bureaucracy.
- Corruption and leakages
- Lack of awareness and education.
- Treating them as just beneficiaries
- Patriarchal setup.
- Caste politics
- Poor values and morals.

The challenges hinder service delivery and deprive them of natural rights. We need to overcome these challenges and help them build capacity to participate in governance.

6. Is Emotional Intelligence influenced by cultural moorings? How would you differentiate the applicability of Emotional Intelligence in Indian society from that of Western society? 10

Emotional Intelligence is a technique aimed at taking better decisions while managing emotions and understanding other emotions for better productivity.

There is a belief that it is influenced by cultural moorings and might not always yield positive results. But in reality Emotional Intelligence calls for self-realization, self-awareness and so it analyses cultural moorings rationally and acts accordingly. Thus it cannot be completely influenced by cultural moorings but respects the cultures.

The emotional intelligence has some difference in its applicability in Indian society when

compared western society.

For example - Indian society had greater communitarianism system, so when one worries about how community feels, the emotions are different to that of west - which is more individualistic.

The emotions might not find value in that western society but are important here. So it is this type of changes that Emotional Intelligence adjusts and provide best results.

This concepts there by aims at respecting the emotions and their meanings and have positive results.

7. Evaluate the success of RTI in bringing governance reforms in the country. Examine whether it has served the purpose it was meant for. 10

Since then it has been of great success in the governance of country. Some major success points

- Greater Transparency and Accountability.
- Participation of people in decision making
- The scams of 2G and 3G are mainly a result of active RTI petitions.
- For example - Gulu Hydroelectric Project in Chhattisgarh got approval without proper Gram Sabha. The RTI petition brought the realities out and public's voice prevailed.
- The awareness and understanding of people increased.

• A shift from beneficiary to Rights respecter

Though the success is positive, there are some lacunas, they are.


- ✓ The protection to RTI activists
- ✓ The quality of information
- ✓ The delays and capability of agencies
- ✓ Political parties not still under RTI
- ✓ Secrets Act overriding RTI
- ✓ Too many exemptions (sec. 8)

Overall the RTI has done significant good to the people's participation, bringing accountability. But this are minor steps and greater steps include reducing exemptions, bringing political parties under RTI, protection to activists must be implemented in order to have long lasting results.

8. The decisive role that money plays in elections creates a vicious cycle of corruption. (a) Elaborate in the context of India. (b) Discuss whether state funding of elections can help in curbing the menace of political corruption in India. 10

Arguments against state funding.

In order to have transparency first political parties internal reforms have to be established.

Only then any idea of funding can be thought off.

But this needs greater debates and deliberations before any implementation. One idea is that political parties rather than elections can be funded

9. You are the officer in charge of development planning of a state whose capital is the technology hub of the country. However, the capital city is overcrowded and marred by traffic congestion. A group of top MNCs have approached you and showed their interest in expanding their operations in the capital provided that the highway connecting the SEZ to airport is widened. This has been cited as an important business requirement. The expansion of MNC operations is expected to create numerous jobs and would bring in huge revenues to the State. At the same time, the road connectivity in rest of the state, especially the rural areas, is abysmal and is in need of urgent attention. Media has been highlighting the incidents of deaths due to delay in hospitalization and other such issues which can be directly attributed to poor condition of roads. As the officer in charge of the development planning you find that the road widening project will entail huge cost and would severely curtail the rural road development programme currently being undertaken by the state. 20

(a) What challenges do you face as the officer in charge, in this situation?

(b) State your priorities and discuss how you plan to achieve them in the context of given challenges.



- 5) Meanwhile, I would rank the crucial roads on their vulnerability and attend priorities adequately.
- 6) I would engage with MNC in order to find an amicable solution for road widening.  
I would request them to start investing in area through their contributions through CSR activities.
- 7) I would take into consideration industrial and employment departments in decision making.

- 8) The centre and higher authorities will be approached and requested for more financial support.
- 9) could give assurance and a viable long term plan of road widening to SEZ.

Thus my decisions will be driven by rationality and optimum utilization of funds and larger interests of people.





 (b) List the issues involved in the case.  
 (c) What will be your plan of action?

This is an example where large number of people are defiant of orders and I was tasked to comply and follow court orders. My actions in this case are guided by integrity, non partiality, rule of law and compassion and persuasion.



a) The reasons for people's defiance could be-

- Their belief that their leader is wrongly convicted
- They don't believe in state rule of law in doing its duty
- They might have been forced by some leaders by threat
- They were helpless to make their own decisions
- They were distorted without any rationality by their sect-cult leaders.

b) The issues involved in the case are.

- Courts orders must be followed and no negotiation in this directives.
- Large number of women and children were obstructing this process.
- Intelligence inputs of violence.
- Need to arrest leader at same time bring change in people without violence.
- No action would cause violence to spread out spread to other regions.

c) The plan of action would be

In this regard I would take into inputs of intelligence, experience of handling such incidents from higher authorities and also local political leaders who could influence people and persuade them. I would be driven by compassion and empathy not to hurt women and children.

- 1) Make a plan to arrest the leader and at some time also re negotiate and persuade the people.
- 2) Use large preparatory forces - to identify key sensitive areas and tighten security in these regions.
- 3) Reduce the notorious mongering through restrictions on mobile and internet services
- 4) I would warn the people of consequences and police action if they don't follow rules
- 5) Make some preventive detections about of key players and suspects.
- 6) Female police unit would take care of women and the children and control their protests.
- 7) While paramilitary police would sanitize the area, with weapons.

Thus in this way I would bring a multi  
pronged attack to bring situation under  
control. The major aim would be persuade people  
without force but if they defy further I would not  
mind using legal action, because courts order  
is ultimate.



11. Ramesh, a very hardworking person, is the sole bread earner in his family. He has worked with an oil company's local affiliate for several years, and has established a strong, trustworthy relationship with Suresh, manager of the local facility. Suresh has recently recommended Ramesh to be recruited as the corporate consulting engineer for the company, which would be a position of greater responsibility along with a stable income. During a casual conversation, Suresh mentions an incident in the 1960s wherein 10,000 gallons of a petrochemical was leaked into the local environment by the company due to negligence, though at the time no damage was found, and no mention of this leak was made to the press. When Ramesh mentions that the state law requires him to report all spills, Suresh reminds him that no harm had been done and reminds him that the company can't have a consulting engineer who does not value loyalty and respect confidentiality.

(c) Had you been at Ramesh's place, what would have been your course of action? Give reasons for the same.



to be prepared for this type of incidents. Environment  
also would work if any real damage is done.

Might bring people movement.

Demerit : Company will lose its face and  
even revenue. There might be problem to  
Ramesh career as this might see use of Suresh.

2) Follow Suresh's advice and not uniform government.

Merit : Since no damage has not been done. this would not be any problem for me and my career growth. company would be without any trouble.

Demerit : This is against rules of state and also against my morals. Even though happened long back accountability has to be fixed. Further accidents might happen and follow same path.

3) Inform government about the case and also inform them of genuine intent. the state should also be informed of preventive steps taken till then and steps to save environment. Some confidence building measures with less punishment.

Merit - This could help the government and company to find a viable solution. Not damage to company reputation and also ~~name~~ Ramesh.

Demerit : The company might not agree to this offer of Ramesh and see protest from people.

The social network offered by your company has emerged as a platform for people to interact with each other and share news, opinions etc. However, at the same time, women are being repeatedly harassed and cyber bullied through this network. Whenever any instance of harassment is brought to notice of the company, your staff members immediately deactivate the account of the culprit. However, since new accounts can be created easily, such incidents continue to happen. Also, the system to verify one's account details has been deemed lax by public authorities and human rights groups. But in order to increase the user base, you have to ensure that it is easy for a new user to sign up. Increase in the user base leads to more advertisements on your network, which is a source of huge annual turnover for the company. At the same time, in wake of increasing instances of harassment, you also need to tighten the process of creating new accounts and deactivate or delete the ones being misused. 20

(a) Highlight the options available to you in this scenario and evaluate each of them. What course of action will you take and why?


(b) Is there a need for having reasonable restrictions on social media for it to remain a platform of healthy and fruitful engagement. Analyse from the viewpoint of different stakeholders.

13. You and your friend are living together in a metropolitan city and preparing for civil service examinations. While you manage to meet your daily targets, you sense that your friend is unable to cope up with the pressure of the exam. Fear of not passing the exam and meeting the expectations of his family is stressing him further. You realise that with time your friend is losing interest in everything and often talks about committing suicide if he is unable to meet his goal. He is also missing out on meals and prefers to stay indoors when asked to venture out. When you sought professional help, the doctor diagnosed your friend with clinical depression. Being aware that your friend needs professional counselling and psychiatric care, you reach out to his parents who reside in a rural area. They rebuff you for suggesting counselling and instead reiterate that nothing is wrong with him. They sternly mention that your bringing up the matter will only make people engage in loose talk. They also ignore you when you politely inform them that it is not wise to ignore one's mental health. Your friend's parents see his state as a sign of failure and decide to call him home where he can continue with his preparation. You are aware of the gravity of the situation if your friend goes back to his house. You also know that there is very little awareness about mental health and that the solution is not to ignore it but to take necessary measures to tackle it. 20

(a) As a concerned friend and an aspiring civil servant who can frame policies for the public in the future and has a moral duty towards them, what are the options available to you in such a situation?

(b) Evaluate each of these options and choose the option you would adopt, giving reasons



Not sure about economic requirements of treatment and doctor charges.

3) I would speak with my friend and also his parents face to face and explain them with some example. Take help of some senior doctors or NGO's working in this field. Try to make parents understand situation and respect his mental state and provide medical health care. I would ask NAB to support here.

Merits - This would mean I am addressing both friends and parents cause at same time.

I would not have any financial burden or any disturbance.

Demerits - It needs tough persuasion to change people's belief and might not be very receptive.

b) Out of these options, I would choose option 3, as this gives him opportunity to rehabilitate and also address the parents queries.

This brings awareness among people, naps and doctors about realities. Had I gone for option 2, this would not be sustainable one of solution.

option 3 is long lasting and also morally correct.

This is in larger interests of society, people and my friend.





14. You are the Managing Director of a multinational company that prides on hiring people from diverse backgrounds. The company also chooses multiple projects under Corporate Social Responsibility that are geared towards social inclusion and empowerment of vulnerable sections of the society. Miss 'X' who works in your office tells you that she has been diagnosed with HIV. It happened due to malpractice by a medical practitioner who re-used a contaminated syringe that led Miss 'X' to contract the disease. The company has strict policies about toleration and you ensure Miss 'X' that she can continue with her job in the company without facing any form of discrimination. A few days after the revelation, Miss 'X' angrily submits her resignation letter. She states that she has faced discrimination at the workplace everyday after the revelation. Her colleagues are hesitant to eat lunch with her, they make sure they do not drink water from the same source and the females in the office comment on her marital status. She is also asked to sit separately during departmental discussions. She intends to sue the company for mental harassment. If she takes the step, the public image of the company will be maligned and its non-discriminatory policies will be questioned. The following are some suggested options for you to deal with the situation as a Managing Director of the company. Evaluate the merits and demerits of each of the options: 20

(a) You accept her resignation and suggest a compensation package so that she refrains from suing the company.

(b) You persuade her not to submit her resignation and transfer her to another department.


(c) You ask her to continue with her job and take strict action against the colleagues who discriminated against her. Also, state (without necessarily restricting to the above options) your course of action, giving proper reasons.

- (c) आप उन्हें उनका जॉब जारी रखने और उनके विरुद्ध भेदभाव करने वाले सहकर्मियों के विरुद्ध कठोर कार्रवाई करने के लिए कहते हैं। साथ ही (अनिवार्य रूप से केवल उपर्युक्त विकल्पों तक ही सीमित रहे बिना) उचित कारण बताते हुए अपनी कार्यवाही भी बताइए।

The above case is social stigmatization against HIV patients. This is against human values. The recent law passed by Parliament will be my guiding principle here. I would also be guided by compassion, empathy and impartiality.



Options Evaluation

a) You accept her resignation and suggest her compensation package so that she refrains from suing the company.

Merits - The image of company is protected.

I would not face any ire of people and management.

Demerits - This is against human values and also against company principles. Law also mandates against this.

This is only shifting the problem but not addressing it. A kind of cowardice act.

b) You persuade her not to submit her resignation and transfer her to another department.

Merit - This would bring respite to her and she will be free from this discrimination. I have solved the problem without any problem to

company image.

Demerit - This is against the true spirit of tolerance.

This means shifting the problem but not addressing it. She might still face the problem in other department. Department habits are not changed.

c) You ask her to continue with her job take strict action against colleagues who discriminate against her.

Merit - This appears to be in line with organization values of not discriminating. The staff will learn lesson and might not be repeated. No problem to image but may increase.

Demerit - This might create negative feeling towards company employees. She might feel neglected indirectly. Productivity and efficiency might come down.

d) I would first create a team to look into these kind of complaints. This would bring confidence in people like Miss 'X'.

I would try to understand the reason for staff behaviour and try to educate them. I would take cue from Aristotle - People do wrong because they do not know it.

I would also create awareness and warn people of dire consequences. If this repeats again. Even if repeats I might strictly act against this.

I would follow option 'd' as this aims to bring change in the attitude of people and internal change which is sustainable. All others would only create external changes.

Most importantly I would create a positive and conducive work culture.
