शाह मल

शाह मल उत्तर प्रदेश के बड़ौत परगना के एक बड़े गाँव के रहने वाले थे। वह एक जाट कुटुम्ब से संबंध रखते थे जो चौरासी देस (चौरासी गाँव) में फैला हुआ था। इस इलाके की ज़मीन सिंचाई की सुविधाओं से लैस और उपजाऊ थी। यहाँ की मिट्टी काली नम थी। बहुत सारे ग्रामीण संपन्न थे और लोग ब्रिटिश भूराजस्व व्यवस्था को दमनकारी मानते थे : लगान की दर ज़्यादा और वसूली सख्त थी। नतीजा यह था कि किसानों की ज़मीन बाहरी लोगों के हाथ में जा रही थी। इलाके में आने वाले व्यापारी और महाजन ज़मीन पर कब्ज़ा करते जा रहे थे।

शाह मल ने चौरासी देस के मुखियाओं और काश्तकारों को संगठित किया। इसके लिए उन्होंने रात के साए में गाँव-गाँव जाकर बात की और लोगों को अंग्रेज़ों के खिलाफ़ विद्रोह के लिए तैयार किया। बहुत सारे दूसरे स्थानों की तरह यहाँ भी अंग्रेज़ों के खिलाफ़ आंदोलन एक व्यापक विद्रोह में तब्दील हो गया। अब विरोध उत्पीड़न और अन्याय के तमाम चिह्नों के खिलाफ़ होने लगा। किसान अपने खेत छोड़कर निकल पड़े और महाजनों व व्यापारियों के घर-बार लूटने लगे। बेदखल भूस्वामियों ने छिन चुकी ज़मीनों पर दोबारा कब्ज़ा कर लिया। शाह मल के आदमियों ने सरकारी इमारतों पर हमला किया, नदी का पुल ध्वस्त कर दिया और पक्की सड़कों को खोद डाला। इसकी एक वजह यह थी कि वे सरकारी फ़ौजों का रास्ता रोकना चाहते थे। दूसरी वजह यह थी कि पुलों और सड़कों को ब्रिटिश शासन का प्रतीक माना जाता था। उन्होंने दिल्ली में विद्रोह करने वाले सिपाहियों को रसद पहुँचाई और ब्रिटिश हेडक्वार्टर व मेरठ के बीच तमाम सरकारी संचार बंद कर दिया। स्थानीय स्तर पर राजा कहलाने वाले शाह मल ने एक अंग्रेज़ अफ़सर के बंगले में डेरा डाला, उसे “न्याय भवन” का नाम दिया और वहीं से झगड़ों और विवादों का फैसला करने लगे। उन्होंने गुप्तचरी का भी हैरतअंगेज़ नेटवर्क स्थापित कर लिया था। कुछ समय के लिए लोगों को लगा कि फ़िरंगी राज खत्म हो चुका है और उनका राज आ गया है।

जुलाई 1857 में शाह मल को युद्ध में मार दिया गया।

**Shah Mal**

Shah Mal lived in a large village in pargana Barout in Uttar Pradesh. He belonged to a clan of Jat cultivators whose kinship ties extended over *chaurasee des* (eighty-four villages). The lands in the region were irrigated and fertile, with rich dark loam soil. Many of the villagers were prosperous and saw the British land revenue system as oppressive : the revenue demand was high and its collection inflexible. Consequently cultivators were losing land to outsiders, to traders and moneylenders who were coming into the area.

Shah Mal mobilised the headmen and cultivators of *chaurasee des*, moving at night from village to village, urging people to rebel against the British. As in many other places, the revolt against the British turned into general rebellion against all signs of oppression and injustice. Cultivators left their fields and plundered the houses of moneylenders and traders. Displaced proprietors took possession of the lands they had lost. Shah Mal’s men attacked government buildings, destroyed the bridge over the river, and dug up metalled roads – partly to prevent government forces from coming into the area, and partly because bridges and roads were seen as symbols of British rule. They sent supplies to the sepoys who had mutinied in Delhi and stopped all official communication between British headquarters and Meerut. Locally acknowledged as the Raja, Shah Mal took over the bungalow of an English officer, turned it into a “hall of justice”, settling disputes and dispensing judgements. He also set up an amazingly effective network of intelligence. For a period the people of the area felt that *firangi raj* was over, and their *raj* had come.

Shah Mal was killed in battle in July 1857.

किसी भी चीज़ का उसके जैसा ही रेखांकन बनाना तसवीर कहलाता है । अपनी युवावस्था के एकदम शुरुआती दिनों से ही महामहिम ने इस कला में अपनी अभिरुचि व्यक्त की है । वे इसे अध्ययन और मनोरंजन दोनों का ही साधन मानते हुए इस कला को हर संभव प्रोत्साहन देते हैं । चित्रकारों की एक बड़ी संख्या इस कार्य में लगाई गई है । हर हफ़्ते शाही कार्यशाला के अनेक निरीक्षक और लिपिक बादशाह के सामने प्रत्येक कलाकार का कार्य प्रस्तुत करते हैं और महामहिम प्रदर्शित उत्कृष्टता के आधार पर ईनाम देते तथा कलाकारों के मासिक वेतन में वृद्धि करते हैं... अब सर्वाधिक उत्कृष्ट चित्रकार मिलने लगे हैं और बिहज़ाद जैसे चित्रकारों की अत्युत्तम कलाकृतियों को तो उन यूरोपीय चित्रकारों के उत्कृष्ट कार्यों के समकक्ष ही रखा जा सकता है जिन्होंने विश्व में व्यापक ख्याति अर्जित कर ली है । ब्योरे की सूक्ष्मता, परिपूर्णता और प्रस्तुतीकरण की निर्भीकता जो अब चित्रों में दिखाई पड़ती है, वह अतुलनीय है । यहाँ तक कि निर्जीव वस्तुएँ भी प्राणवान प्रतीत होती हैं । सौ से अधिक चित्रकार इस कला के प्रसिद्ध कलाकार हो गए हैं । हिंदू कलाकारों के लिए यह बात खासतौर पर सही है । उनके चित्र वस्तुओं की हमारी परिकल्पना से कहीं परे हैं । वस्तुतः पूरे विश्व में कुछ लोग ही उनके समान पाए जा सकते हैं ।

### **In praise of *taswir***

Abu'l Fazl held the art of painting in high esteem :

Drawing the likeness of anything is called *taswir*. His Majesty from his earliest youth, has shown a great predilection for this art, and gives it every encouragement, as he looks upon it as a means both of study and amusement. A very large number of painters have been set to work. Each week, several supervisors and clerks of the imperial workshop submit before the emperor the work done by each artist, and His Majesty gives a reward and increases the monthly salaries of the artists according to the excellence displayed. ... Most excellent painters are now to be found, and masterpieces, worthy of a Bihzad, may be placed at the side of the wonderful works of the European painters who have attained worldwide fame. The minuteness in detail, the general finish and the boldness of execution now observed in pictures are incomparable; even inanimate objects look as if they have life. More than a hundred painters have become famous masters of the art. This is especially true of the Hindu artists. Their pictures surpass our conception of things. Few, indeed, in the whole world are found equal to them.

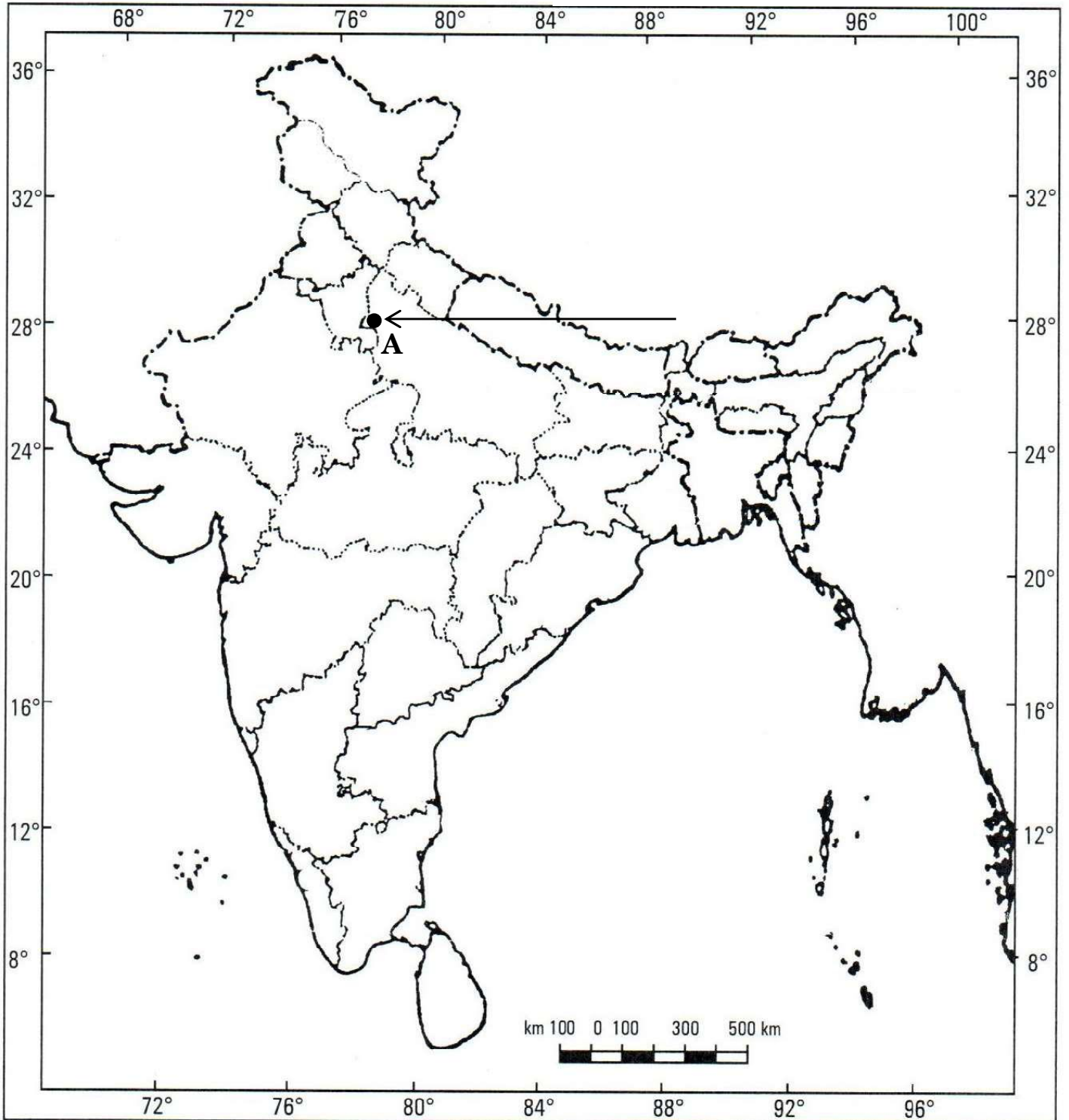

**General Instructions: -**

1. You are aware that evaluation is the most important process in the actual and correct assessment of the candidates. A small mistake in evaluation may lead to serious problems which may affect the future of the candidates, education system and teaching profession. To avoid mistakes, it is requested that before starting evaluation, you must read and understand the spot evaluation guidelines carefully.
2. **“Evaluation policy is a confidential policy as it is related to the confidentiality of the examinations conducted, Evaluation done and several other aspects. Its’ leakage to public in any manner could lead to derailment of the examination system and affect the life and future of millions of candidates. Sharing this policy/document to anyone, publishing in any magazine and printing in News Paper/Website etc may invite action under IPC.”**
3. Evaluation is to be done as per instructions provided in the Marking Scheme. It should not be done according to one’s own interpretation or any other consideration. Marking Scheme should be strictly adhered to and religiously followed. **However, while evaluating, answers which are based on latest information or knowledge and/or are innovative, they may be assessed for their correctness otherwise and marks be awarded to them. 4. The Head-Examiner must go through the first five answer books evaluated by each evaluator on the first day, to ensure that evaluation has been carried out as per the instructions given in the Marking Scheme. The remaining answer books meant for evaluation shall be given only after ensuring that there is no significant variation in the marking of individual evaluators.
5. Evaluators will mark(  $\checkmark$  ) wherever answer is correct. For wrong answer ‘X’ be marked. Evaluators will not put right kind of mark while evaluating which gives an impression that answer is correct and no marks are awarded. **This is most common mistake which evaluators are committing.**
6. If a question has parts, please award marks on the right-hand side for each part. Marks awarded for different parts of the question should then be totaled up and written in the left-hand margin and encircled. This may be followed strictly.
7. If a question does not have any parts, marks must be awarded in the left-hand margin and encircled. This may also be followed strictly.
8. If a student has attempted an extra question, answer of the question deserving more marks should be retained and the other answer scored out.
9. No marks to be deducted for the cumulative effect of an error. It should be penalized only once.

10. A full scale of marks \_\_\_\_\_(example 0-40 marks as given in Question Paper) has to be used. Please do not hesitate to award full marks if the answer deserves it.
11. Every examiner has to necessarily do evaluation work for full working hours i.e. 8 hours every day and evaluate 30 answer books per day in main subjects and 35 answer books per day in other subjects (Details are given in Spot Guidelines). This is in view of the reduced syllabus and number of questions in question paper.
12. Ensure that you do not make the following common types of errors committed by the Examiner in the past:-

13. While evaluating the answer books if the answer is found to be totally incorrect, it should be marked as cross (X) and awarded zero (0) Marks.
14. Any unassessed portion, non-carrying over of marks to the title page, or totaling error detected by the candidate shall damage the prestige of all the personnel engaged in the evaluation work as also of the Board.
