1. What fraction of tritium will remain after 25 years? Given half life of tritium as 12.5 years

Ans.

2.Calculate the kinetic energy and potential energy of an electron in the first orbit of hydrogen atom. Given  $e = 1.6 \times 10^{-19} C$  and  $r = 0.53 \times 10^{-10} m$ .

Ans.(i)  $K.E. = \frac{e^2 K}{2a_0}$   $K.E. = \frac{(1.6 \times 10^{-19})^2 \times 9 \times 10^9}{2 \times 0.53 \times 10^{-10}}$   $K.E. = 21.74 \times 10^{-19} J$   $K.E. = 21.74 \times 10^{-19} J$   $K.E. = \frac{21.74 \times 10^{-19}}{1.6 \times 10^{-19}} = 13.59 eV$ (ii)  $P.E. = \frac{-e^2 K}{r} = -2K.E.$   $P.E. = -2 \times 13.59$ P.E. = -27.18 eV

#### 3. Why is nuclear fusion not possible in laboratory?

**Ans.** Nuclear fusion is not possible in laboratory as it is performed in high temperature. This cannot be attained in the laboratory.

Ans.  $E = mc^{2}$ =  $16 \times 10^{-6} Kg (3 \times 10^{8} m / s)^{2}$ =  $16 \times 9 \times 10^{10}$  Joules  $E = \frac{16 \times 9 \times \times 10^{10}}{1.6 \times 10^{-19}} eV$  $E = 9 \times 10^{30} eV$ 

5.The three stable isotopes of neon:  ${}^{20}_{10}Ne_{\pm}{}^{21}_{10}Ne$  and  ${}^{22}_{10}Ne$  have respective abundances of 90.51%, 0.27% and 9.22%. The atomic masses of the three isotopes are 19.99 u, 20.99 u and 21.99 u, respectively. Obtain the average atomic mass of neon.

Abundance of,  $\eta_1 = 90.51\%$ 

Atomic mass of,  $m_2 = 20.99u$

Abundance of,  $\eta_3 = 9.22\%$ 

The average atomic mass of neon is given as:

$$m = \frac{m_1 \eta_1 + m_2 \eta_2 + m_3 \eta_3}{\eta_1 + \eta_2 + \eta_3}$$
$$= \frac{19.99 \times 90.51 \times 20.99 \times 0.27 \times 21.99 \times 9.22}{90.51 + 0.27 + 9.22}$$

= 20.1771u

6. From the relation  $R = R_0 A^{1/3}$ , where R0is a constant and A is the mass number of a nucleus, show that the nuclear matter density is nearly constant (i.e. independent of A).

Ans. We have the expression for nuclear radius as:

$$R = R_0 A^{1/3}$$
 Where,

*R*0= Constant.

A= Mass number of the nucleus

Nuclear matter density,  $\rho = \frac{Mass of the nucleus}{Volume of me nucleus}$ 

Let *m* be the average mass of the nucleus.

Hence, mass of the nucleus = *mA* 

$$\therefore p = \frac{mA}{\frac{4}{3}\pi R^3} = \frac{3mA}{4\pi \left(R_0 A^{\frac{1}{5}}\right)^3} = \frac{3mA}{4\pi R_0^3 A} = \frac{3m}{4\pi R_0^3}$$

Hence, the nuclear matter density is independent of A. It is nearly constant.

Ans. 
$$\frac{A}{A_o} = \left(\frac{1}{2}\right)^{\frac{4}{T}}$$
$$\frac{1}{8} = \left(\frac{1}{2}\right)^{\frac{30}{T}}$$

$$\left(\frac{1}{2}\right)^3 = \left(\frac{1}{2}\right)^{3\frac{N}{T}}$$
$$\Rightarrow \frac{30}{T} = 3$$

Or

T = 10 years

### 3.Show that nuclear density is in dependent of mass number A of a nucleus?

Ans. Nuclear density =  $\frac{\text{Mass of nucleus}}{\text{Volume of nucleus}} = \frac{(\text{Mass of P or N}) \times A}{\text{Volume of Nucleus}}$  $P = \frac{(1.6 \times 10^{-27})A}{\frac{4}{3}\pi R^3} = \frac{(1.6 \times 10^{-27}) \times A}{\frac{4}{3}\pi \left(R_o A^{\frac{1}{3}}\right)^3}$ 

Here  $R_o = 1.2 \times 10^{-15} m$ 

$$\Rightarrow P = \frac{(1.6 \times 10^{-27}) \times A}{\frac{4}{3} \pi R_o^3 A} = \frac{1.6 \times 10^{-27}}{\frac{4}{3} \times 3.14 \times (1.2 \times 10^{-15})^3}$$

 $\Rightarrow P = 2.21 \times 10^{17} Kg / m^3$ 

#### 4. A radioactive nucleus undergoes a series of decay according to the scheme

$$A \xrightarrow{\alpha} A_1 \xrightarrow{\beta} A_2 \xrightarrow{\alpha} A_3 \xrightarrow{\gamma} A_4$$

If the mass number and atomic number of A are 180 and 72 respectively, what are there

number for A<sub>4</sub>?

Ans. 
$${}^{180}_{72}A \longrightarrow {}^{\alpha}_{70} \xrightarrow{A_1}{}^{176}_{70} \xrightarrow{\beta}{}^{-}_{71} \xrightarrow{176}{}^{176}_{71} \xrightarrow{\alpha}{}^{172}_{69} \xrightarrow{\gamma}{}^{\gamma}_{4}$$

### 5. Distinguish between isotopes and isobars. Give one example for each of the species?

**Ans.**The elements which have same atomic number but different mass number are called Isotopes.

For eg  $\rightarrow 6c^{10} 6c^{11} 6c^{12} 6c^{14}$  (Isotopes of carbon)

Thus nuclides of different elements having same mass number but different atomic number are called isobars.

For eg  $\rightarrow {}_{1}\overset{3}{H}$  and  ${}_{2}\overset{3}{He}$  ${}_{3}\overset{7}{\text{Li}}$  and  ${}_{4}\overset{7}{\text{Be}}$ 

# 6. A radio active nuclide decays to form a stable nuclide its half life is 3 minutes. What fractions of its 1g will remain radioactive after 9 minutes?

Ans.Suppose no. of atoms/gram = No

t = 9 minutes

$$T_{\frac{1}{2}} = 3 \text{ minutes}$$

$$\frac{N}{No} = \left(\frac{1}{2}\right)^{\frac{1}{2}} = \left(\frac{1}{2}\right)^{\frac{3}{2}} = \left(\frac{1}{2}\right)^{\frac{3}{2}} = \frac{1}{8}$$

$$\Rightarrow N = \frac{No}{8}$$

 $\Rightarrow \text{Fraction decayed} = \frac{No - N}{No} = \frac{No - \frac{No}{8}}{No}$  $= 1 - \frac{1}{8} = \frac{7}{8} = 0.875$ 

Fraction remain undecayed = 1 – 0.875 = 0.125

7. Obtain the binding energy (in MeV) of a nitrogen nucleus  ${}^{14}_7N$ , given  $m\binom{14}{7}N$ =14.00307 u

**Ans.** Atomic mass of nitrogen  $\binom{7}{2}N^{14}$ , m = 14.00307 u

A nucleus of nitrogen  $_7 N^{14}$  contains 7 protons and 7 neutrons.

Hence, the mass defect of this nucleus,  $\Delta m = 7m_H + 7m_n - m$ 

Where,

Mass of a proton,  $m_H$  = 1.007825 u

Mass of a neutron,  $m_n = 1.008665$  u

 $\therefore \Delta m = 7 \times 1.007825 + 7 \times 1.008665 - 14.00307$ 

= 7.054775 + 7.06055 - 14.00307

 $But \, 1 \, u = 931.5 \, MeV \, / \, c^2$ 

 $\therefore \Delta m = 0.11236 \times 931.5 \, MeV \, / \, c^2$ 

Hence, the binding energy of the nucleus is given as:

$$Eb = \Delta mc^2$$

Where,

c= Speed of light

$$\therefore Eb = 0.11236 \times 931.5 \left(\frac{MeV}{c^2}\right) \times c^2$$

= 104.66334 MeV

Hence, the binding energy of a nitrogen nucleus is 104.66334 MeV.

8. Obtain approximately the ratio of the nuclear radii of the gold isotope  ${}^{197}_{79}Au$  and the silver isotope  ${}^{107}_{47}Ag$ .

**Ans.** Nuclear radius of the gold isotope  $_{79}au^{197} = R_{Au}$ 

Nuclear radius of the silver isotope  $_{47}Ag^{107} = R_{Ag}$ 

Mass number of gold,  $A_{Au}$  = 197

Mass number of silver,  $A_{Ag}$  = 107

The ratio of the radii of the two nuclei is related with their mass numbers as:

$$\frac{R_{Au}}{R_{Ag}} = \left(\frac{R_{Au}}{R_{Ag}}\right)^{\frac{1}{3}}$$
$$= \left(\frac{197}{107}\right)^{\frac{1}{3}} = 1.2256$$

Hence, the ratio of the nuclear radii of the gold and silver isotopes is about 1.23.

9.Suppose, we think of fission of a  ${}_{26}^{56}Fe$  nucleus into two equal fragments,  ${}_{13}^{28}Al$ . Is the fission energetically possible? Argue by working out Q of the process. Given

$$m\left({}^{56}_{26}Fe\right) = 55.93494u \text{ and } m\left({}^{28}_{13}Al\right) = 27.98191u.$$

**Ans.** The fission of  $\frac{56}{26}Fe$  can be given as:

$${}^{56}_{13}Fe \rightarrow 2{}^{28}_{13}Al$$

It is given that:

Atomic mass of  $m\left(\frac{56}{26}Fe\right) = 55.93494$  u Atomic mass of  $m\left(\frac{28}{13}Al\right) = 27.98191u$ 

The Q-value of this nuclear reaction is given as:

$$Q = \left[ m \left( \frac{56}{26} Fe \right) - 2m \left( \frac{28}{13} Al \right) \right] c^{2}$$
$$= \left[ 55.93494 - 2 \times 27.98191 \right] c^{2}$$
$$= \left( 0.02888c^{2} \right) u$$
But 1u = 931.5 MeV / e^{2}

 $\therefore Q = -0.02888 \times 931.5 = -26.902 MeV$ 

The *Q*-value of the fission is negative. Therefore, the fission is not possible energetically. For an energetically-possible fission reaction, the *Q*-value must be positive.

10.The fission properties of  ${}^{234}_{94}Pu$  are very similar to those of  ${}^{235}_{92}U$ . The average energy released per fission is 180 MeV. How much energy, in MeV, is released if all the atoms in 1 kg of pure  ${}^{239}_{94}Pu$  undergo fission?

Ans. Average energy released per fission of  $^{239}_{94}Pu$  ,  $E_{av}=180 MeV$ 

Amount of pure  $_{94}Pu^{239}$ , m = 1 kg = 1000 g

NA= Avogadro number =  $6.023 \times 10^{23}$ 

Mass number of  ${}^{239}_{94}Pu$  = 239 g

1 mole of  ${}_{94}Pu^{239}$  contains NAatoms.

$$\therefore mg \text{ of }_{94} Pu^{239} \text{ contains} \left( \frac{N_A}{Mass \ number} \times m \right) atoms$$
$$= \frac{6.023 \times 10^{23}}{239} \times 1000 = 2.52 \times 10^{24} \ atoms$$

 $\therefore$ Total energy released during the fission of 1 kg of  $_{94}^{239}Pu$  is calculated as:

$$E = E_{av} \times 2.52 \times 10^{24}$$
$$= 180 \times 2.52 \times 10^{24} = 4.536 \times 10^{26} MeV$$

Hence,  $4.536 \times 10^{26} MeV$  is released if all the atoms in 1 kg of pure  $_{94}Pu^{299}$  undergo fission.

11. Calculate the height of the potential barrier for a head on collision of two deuterons. (Hint: The height of the potential barrier is given by the Coulomb repulsion between the two deuterons when they just touch each other. Assume that they can be taken as hard spheres of radius 2.0 fm.)

Ans. When two deuterons collide head-on, the distance between their centres, *d* is given as:

Radius of 1stdeuteron + Radius of 2nddeuteron

Radius of a deuteron nucleus = 2 fm =  $2 \times 10^{-15} m$ 

 $d = 2 \times 10^{-15} + 2 \times 10^{-15} = 4 \times 10^{-15} m$ 

Charge on a deuteron nucleus = Charge on an electron =  $e=1.6 \times 10^{-19}C$ 

Potential energy of the two-deuteron system:

$$V = \frac{e^2}{4\pi \in_0 d}$$

Where,

 $\in_{\mathbb{Q}}$  = Permittivity of free space

$$\frac{1}{4\pi \in_0} = 9 \times 10^9 Mm^2 c^{-2}$$
$$\therefore V = \frac{9 \times 10 \times (1.6 \times 10^{-19})^2}{4 \times 10^{-15}} J$$
$$= \frac{9 \times 10^9 \times (1.6 \times 10^{-19})^2}{4 \times 10^{-15} \times (1.6 \times 10^{-19})^2} eV$$

= 360 keV

Hence, the height of the potential barrier of the two-deuteron system is 360 keV.

**Ans.**We know  $\frac{1}{\lambda} = R\left(\frac{1}{2^2} - \frac{1}{ni^2}\right), n = 3, 4, 5 - -$ 

For first member ni = 3 (Balmer series)

$$\frac{1}{\lambda_1} = R\left(\frac{1}{2^2} - \frac{1}{3^2}\right)$$

$$\frac{1}{\lambda_1} = R\left(\frac{1}{4} - \frac{1}{9}\right)$$
$$\lambda_1 = \frac{36}{5R} - \dots - (1)$$

For first member of Lyman series

 $\frac{1}{\lambda_1'} = R\left(\frac{1}{1^2} - \frac{1}{2^2}\right)$  $\frac{1}{\lambda_1'} = R\left(1 - \frac{1}{4}\right)$ 

Or

$$\lambda_1' = \frac{4}{3R}$$
 ------ (2)

From (1) and (2)

$$\frac{\lambda_1'}{\lambda_1} = \frac{4}{3R} \times \frac{5R}{36}$$
$$\frac{\lambda_1'}{\lambda_1} = \frac{5}{27} \lambda_1$$
$$\lambda_1 = 6563 A^\circ$$

 $\Rightarrow \lambda_1' = 1215.4 A^{\circ}$

Given mass of  $3Li^{6} = 6.015126$  a.m.u. Mass of  $2He^{4} = 4.00026044$  a.m.u. Mass of neutron  $\binom{1}{on} = 1.0086654$  a.m.u.

Mass of tritium  $\begin{pmatrix} 1 \\ 1 \end{pmatrix} = 3.016049 a.m.u.$ 

Ans. Nuclear reaction is given by

 $o \stackrel{1}{n+3Li} \rightarrow 2 \stackrel{4}{He+_1H}$ 

Mass of reactants =  $m \left( o n \right) + m \left( 3 L i \right)^{6}$ 

=1.0086654+6.015126=7.0237914 a.m.u

Mass Defect,  $\Delta m$  = mass of reactant – mass of product.

 $\Delta m = 7.0237194 - 7.0186534$ 

 $\Delta m = 0.005138 \text{ a.m.u.}$ 

Since1. a.m.u. = 931MeV

 $\therefore$  Energy released =  $\Delta m \times 931 \text{MeV}$ 

 $E = 0.005138 \times 931$ 

E = 4.783 MeV

3.Define decay constant of a radioactive sample. Which of the following radiation  $\alpha$ -rays,  $\beta$ -rays and  $\gamma$ -rays.

(i) Are similar to X – rays?

## (ii) Are easily absorbed by matter?

Ans. Radioactive decay constant  $(\lambda)$  is the reciprocal of time during which the number of atoms in the radioactive substance reduced to 36.8% of the original number of atoms in it.

(i) are similar to X - rays

(ii) Penetration power of  $\alpha$ -rays is less than that of  $\beta$  and  $\gamma$ -rays so  $\gamma$ -rays are easily absorbed by matter.

4.State radioactive decay law and hence derive the relation  $N = N_o e^{-\lambda t}$  where symbols their usual meanings.

**Ans.** According to radioactive decay law the rate of disintegration of a radioactive substance at an instant is directly proportional to the number of nuclei in the radioactive substance at that time i.e.

 $N = N_o e^{-\lambda t}$  Where symbols have their usual meanings

Consider a radioactive substance having No atoms initially at time (t = o). After time (t) no. of atoms left undecayed be N.

If dN is the no. of atoms decayed in tine dt then according to radioactive decay law

$$\frac{-dN}{dt}\alpha N \text{ or } \frac{-dN}{dt} = \lambda N - \dots - (1)$$

Where  $\lambda$  is decay constant and negative sign indicates that a radioactive sample goes on decreasing with time. Equation (1) can also be written as

$$\frac{dN}{N} = -\lambda dt$$

Integrating both the sides

 $\log e N = \lambda t + K ----(2)$ 

Where K is constant of integration

When t = o, N = No

 $\Longrightarrow$  K = loge No

Substituting K in equation (2)

$$\frac{W}{e} N = \log e No = -\lambda t (\because \log e m - \log e n = \log e^{m}/n)$$
  
$$\log e \frac{N}{No} = -\lambda t$$
  
$$\frac{N}{No} = e^{-\lambda t}$$
  
$$N = No e^{-\lambda t}$$

# 5. Define half life and decay constant of a radioactive element. Write their S.I. unit. Define expression for half life?

**Ans.**The time during which half of the atoms of the radioactive substance disintegrates is called half life of a radioactive substance.

We know 
$$N = Noe^{-\lambda t}$$
  
When  $t = T \frac{1}{2} (Half life)$ 

$$N = \frac{No}{2}$$

$$\Rightarrow \frac{No}{2} = Noe^{-\lambda T \frac{N}{2}}$$

$$\frac{1}{2} = e^{-\lambda T \frac{N}{2}}$$
or  $e^{\lambda T \frac{N}{2}} = 2$ 

$$\lambda T \frac{1}{2} = \log 2$$

$$\lambda T \frac{1}{2} = 2.303 \times \log_{10} 2$$

$$\lambda T \frac{1}{2} = 2.303 \times 0.3010$$

$$T \frac{1}{2} = \frac{0.6931}{\lambda}$$

S.I. unit – second (s)

<u>Radioactive decay constant</u>  $(\lambda)$  is the reciprocal of the time during which the number of atoms in the radioactive substance reduces to 36.8 % of the original number of atoms in it.

SI. unit  $-s^{-1}or min^{-1}$ 

# 6.Draw a curve between mass number and binding energy per nucleon. Give two salient features of the curve. Hence define binding energy?

**Ans.** The total energy required to disintegrate the nucleus into its constituent particles is called binding energy of the nucleus.



Salient features of the curve

(1) The intermediate nuclei have large value of binding energy per nucleon, so they are most stable. (For 30 < A > 63)

(2) The binding energy per nucleon has low value for both the light and heavy nuclei. So they are unstable nuclei.

7.(a) Two stable isotopes of lithium  ${}_{3}^{6}Li$  and  ${}_{3}^{7}Li$  have respective abundances of 7.5% and 92.5%. These isotopes have masses 6.01512 u and 7.01600 u, respectively. Find the atomic mass of lithium.

(b) Boron has two stable isotopes,  ${}_5^{10}B$  and  ${}_5^{11}B$ . Their respective masses are 10.01294 u and 11.00931 u, and the atomic mass of boron is 10.811 u. Find the abundances of  ${}_5^{10}B$  and  ${}_5^{11}B$ .

Ans. (a) Mass of lithium isotope  ${}_{3}^{6}Li$ ,  $m_{1}$  = 6.01512 u

Mass of lithium isotope  $\frac{7}{3}Li$ ,  $m_2 = 7.01600$  u

Abundance of  ${}_{3}^{6}Li$ ,  $\eta_{1}$  = 7.5% Abundance of  ${}_{3}^{7}Li$ ,  $\eta_{2}$  = 92.5%

The atomic mass of lithium atom is given as:

$$m = \frac{m_1 \eta_1 + m_2 \eta_2}{\eta_1 + \eta_2}$$
$$= \frac{6.0512 \times 7.5 \times 7.01600 \times 92.5}{92.5 + 7.5}$$

= 6.940934u

(**b**) Mass of boron isotope  ${}^{10}_{5}$ B ,  $m_1$  = 10.01294 u

Mass of boron isotope  ${}^{11}_{5}$ B,  $m_2$  = 11.00931 u

Abundance of ,  $\eta_1 = x\%$ ,

Abundance of 
$$\eta_2 = (100 - x)\%$$

Atomic mass of boron, *m*= 10.811 u

The atomic mass of boron atom is given as:

 $m = \frac{m_1 \eta_1 + m_2 \eta_2}{\eta_1 + \eta_2}$ 

$$10.811 = \frac{10.01294 \times x + 11.00931 \times (100 - x)}{x + 100 - x}$$

$$1081.11 = 10.01294x + 1100.931 - 11.00931x$$

$$\therefore x = \frac{19.821}{0.99637} = 19.89\%$$

And 100 - *x*= 80.11%

Hence, the abundance of  ${}^{10}_{5}$ B is 19.89% and that of  ${}^{11}_{5}$ B is 80.11%.

8.Obtain the binding energy of the nuclei  ${}_{26}^{56}Fe$  and  ${}_{83}^{209}Bi$  in units of MeV from the following data:  $m\left({}_{26}^{56}Fe\right)$  = 55.934939 u  $m\left({}_{83}^{209}Bi\right)$  = 208.980388 u

**Ans.** Atomic ass of  ${}^{56}_{26}Fe_{=}m_1 = 55.934939$  u

 ${}^{56}_{26}Fe$  nucleus has 26 protons and (56 - 26) = 30 neutrons

Hence, the mass defect of the nucleus,  $\Delta m = 26 \times m_H + 30 \times m_n - m_1$ 

Where,

When the organism is dead, its interaction with the atmosphere (which maintains the above equilibrium activity) ceases and its activity begins to drop. From the known half-life (5730 years) of  ${}_{6}^{14}C$ , and the measured activity, the age of the specimen can be approximately estimated. This is the principle of  ${}_{6}^{14}C$  dating used in archaeology. Suppose a specimen from Mohenjodaro gives an activity of 9 decays per minute per gram of carbon. Estimate the approximate age of the Indus-Valley civilisation.

It can be inferred that if  $Q_2 > 0$ , then  $Q_1 > 0$ ; Also, if  $Q_1 > 0$ , it does not necessarily mean that  $Q_2 > 0$ .

In other words, this means that if  $\beta^+$  emission is energetically allowed, then the electron capture process is necessarily allowed, but not vice-versa. This is because the *Q*-value must be positive for an energetically-allowed nuclear reaction.

22. In a periodic table the average atomic mass of magnesium is given as 24.312 u. The average value is based on their relative natural abundance on earth. # 28. Calculate and compare the energy released by a) fusion of 1.0 kg of hydrogen deep within Sun and b) the fission of 1.0 kg of $^{235}$ U in a fission reactor.

Ans. (a) Amount of hydrogen, m=1 kg = 1000 g

1 mole, i.e., 1 g of hydrogen  $\binom{1}{1}H$  contains  $6.023 \times 10^{23}$  atoms.

 $\therefore$ 1000 g of  ${}^{1}_{1}H$  contains 6.023  $\times$  10<sup>23</sup>  $\times$  1000 *atoms*.

Within the sun, four  ${}^{1}_{1}H$  nuclei combine and form one  ${}^{4}_{2}H$  nucleus. In this process 26 MeV of energy is released.

Hence, the energy released from the fusion of 1 kg  ${}^{1}_{1}H$  is:

$$E_1 = \frac{6.023 \times 10^{23} \times 26 \times 10^3}{4} = 39.1495 \times 10^{26} MeV$$
