## SOLUTION

- 2. **Bassanio:** Bassanio was a young handsome nobleman, who didn't have any money. He wanted to marry a beautiful lady named Portia. Bassanio and Antonio were very good friends.
- 3. **Shylock:** Shylock was a miserly moneylender. He was very rich but only cared for money. He hated Antonio because Antonio sometimes lent money to people without charging interest. # SOLUTION

Partia's father had set a test for his daughter's suitors. They had to choose between three caskets - one of gold, one of silver and one of lead. Each casket had something

written on it. On the gold casket it was written, 'Whoever chooses me shall gain what men desire'; on the silver casket, 'Whoever chooses me shall get as much as he deserves'; on the casket of lead, 'Whoever chooses me must give and hazard all he has'. Inside the gold casket was the message, "All that glitters is not gold". The lead casket was the right casket.

## SOLUTION

When the lawyer saw that Shylock would not change his mind, the lawyer told Shylock to cut off a pound of Antonio's flesh. #### SOLUTION

First, the Duke asked Shylock to show mercy towards Antonio. Shylock was not ready to do so. Then a young lawyer entered the court to fight Antonio's case. The lawyer appealed to Shylock's sense of mercy. Shylock refused to give in. Then the lawyer told Shylock to go ahead and cut off a pound of Antonio's flesh, but without shedding a drop of blood. Also, he should cut exactly one pound of flesh - nothing less, nothing more. Shylock realized that he could not do what the young lawyer asked him to do and accepted defeat. Thus Antonio was saved.
