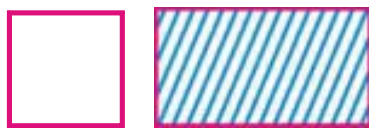
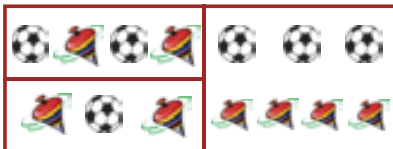
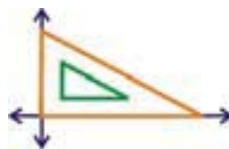
FUNDAMENTAL DUTIES
