**MEMORANDUM**

Sub : Clarification regarding fixation of pay of Govt. employees  
promoted to higher / posts with higher pay structure. ½

The undersigned is directed to refer to the provisions contained in Rule 8 of / ¾  
TSCS (Revised Pay) Rules 2009 which states that the pay of direct recruits to a  
particular posts carrying a // specific Grade pay shall be fixed on or after the 1  
01-01-2006 at the entry level pay / in the pay band as indirect in Part-E read with Part-D 1¼  
of Schedule-1 of / this Rules. In the case of promotion on or after 01-01-2006, if the 1½

concerned / employee has opted for revised pay in terms of TSCS (Revised Pay) Rules 2009 in his lower post then // his pay in the higher post due to promotion shall be fixed under the provisions of Rule 12 of TSCS / (Revised Pay) Rules, 2009.

Several Departments have made references to Finance Department seeking clarification on fixation of / pay of those Govt. employees, who having opted to re-fix their pay in the lower post in terms of / TSCS (Revised Pay) Rules 2009, subsequently gets promoted to higher post during the period of effect of TSCS // (Revised Pay) Rules 2009, and receives lower pay than the entry pay in the revised pay structure for / direct recruits appointed on or after 01-01-2006 as indicated in Part-E read with / Part-D of Schedule-1 of TSCS (Revised Pay) Rules 2009.

The matter has been examined / in Finance Department and after careful examination, it has been clarified that the pay of those Govt. employees who // have been drawing revised pay in the lower post in terms of TSCS (Revised Pay) Rules 2009 and subsequently / gets promoted to higher post during the period under TSCS (Revised Pay) Rules, 2009 shall not receive pay / lower than the entry pay as indicated in Part-E read with Part-D of Schedule-1 / of TSCS (Revised Pay) Rules, 2009.

You can either pick a three-year LLB program or a five-/year integrated BA 2¾  
 LLB course. If you have qualified 10 + 2 / higher secondary school examination /  
 intermediate // examination or equivalent and have an urge for legal field, you can 3  
 look in for the five year integrated BA / LLB course. Otherwise if you feel to join it 3¼  
 after graduation, you can go for the LLB program / after being graduated. 3½

Here is what Dr. Thomas Mahew, Co-Convenor of the Common Law Admission Test (CLAT) / 2014 Committee, shares with you “Bachelor of Law (LLB) is a traditional 3 year long degree // which students can pursue after having completed their Bachelors degree. Bachelor of Arts, Bachelor of Law (BA / LLB) is an integrated degree for students whose objective is very clear. With this course, student will be/able to focus more. Besides the theoretical knowledge, students are also given practical experience of court.”

What / are the Law exams I need to take ? 4¾

The interested candidates who wish to take up law as career // need to qualify any of the entrance examinations listed below :

CLAT: Common Law Admission Test, commonly known / as CLAT is the national level law entrance exam. You can take this admission test to secure a seat / in any of the 14 National Law Universities (NLU), TNNLS Tiruchirappalli, DSNLU Visakhapatnam, Nirma Ahmedabad etc./

LSAT: Law School Admission Test, commonly known as LSAT is a standardized test of reading and verbal reasoning // skills designed by the USA – based Law School Admission Council (LSAC) for use by law school in India/.

DU LLB / LLM : Faculty of Law, University of Delhi conducts a separate law entrance exam. For / admissions to various law courses namely LLB and LLM courses.

SET – SET is common written test conducted for / taking admission to 6¾ undergraduate law programs.

ULSAT is conducted by the University of Petroleum and Energy Studies (UPES).// 7
