1. Read the passage carefully and answer the questions that follow: **12**
- (a) LAPROSCOPY, which was used to remove gall bladder, will be used in various kinds of surgery for the advantages it has over the techniques such as small incision, reduced post operative pain and short hospital stay. One of the major difficulties in laproscopic surgery that the key hole surgery has been the stitching of tissues. So expensive mechanical devices called staplers are used to overcome the difficulty. But the stitching, called suturing and knotting, using laproscopy obviates the need for these tools and add considerably to the kinds of surgeries which can be done laproscopically.
- (b) The department of Surgery of the All India Institute of Medical Sciences has organised a two day workshop on various advanced laproscopic techniques. The workshop is the largest of its kind in the country giving hands on experience in a stimulated environment using 20 state of the art “endo trainer stations”, As many as 200 delegates, surgeons of many year’s experience and faculty members of medical colleges from all over the country are attending the workshop. In open surgery doctors are first taught to put stitches. In the laproscopic surgery of gall bladder using a stapler to put the stitches is alright as there are few stitches but in some cases, such as liver surgery, stapler can’t be used as it is feared that the stapler might give way and the patient bleed to death. Hence “Suturing and knotting is the best”, said Dr. Arvind Kumar, Associate Professor in the Department of Surgery.
- (c) “By doing away with the use of stapler the cost of the surgery can be brought down considerably as the stapler as well as the staples are quite expensive”, said Dr. Arvind Kumar. In laproscopy a tiny telescope is inserted through a small hole in the area being operated upon. The doctor insert the instruments for operating through other small holes and operates by looking at the image of the insides as projected on a screen from the telescope that has been inserted. Suturing and knotting looking at a screen require a high degree of precision and eye-hand co-ordination.

- (d) A lot of training is needed to master this kind of suturing and knotting. "In Laproscopic suturing and knotting, the doctor never comes into the contact with tissues. He has to do using long instruments inserted into the body which have to be used like extensions of the fingers. This is more demanding on the surgeons skills and they need workshops to learn and not patients", said Dr. Michael JMC Mahon of the Leeds Institute of Minimally invasive Surgery one has to teach the participants in the workshop.
- (e) The advantage of endotrainers in doctors can learn to stitch tissues in laproscopy without using human as guinea pigs. The doctors train by stitching tissue simulators or animal tissues. "A single workshop cannot teach them enough but one workshop is better than no workshops. This workshop is to serve as a trendsetter for similar continuing education programmes on laproscopic suturing and knotting all over the country", said Dr. Kumar. The technique is better adopted by younger surgeons as it is difficult for a surgeon used to following the open surgery method to change and relearn new techniques, said Dr. M. C. Mishra of the surgery department.

Tourism has emerged as the world's largest industry. Growing rapidly in the last two decades, today it accounts for 6% of world output and employs some 100 million people around the globe. It has developed immense revenue and development potential and stands today as a unique natural renewable resource industry.

Tourism—the travel based recreation provides people with a change of visiting a place and a break from the monotony of daily life. It brings people of different nations together, allowing them to come into close contact with each other's customs and other aspects of life. The knowledge and experience gained in the process can lead to greater understanding and tolerance and can even foster world peace. A study conducted by the United Nations has shown that developing countries, in particular, can reap handsome benefits out of tourism which greatly boosts national income.

Tourism generates employment and adds to the entrepreneurial wealth of a nation. To promote safe tourism it is imperative to understand the factors that hempen the growth of tourism and check them effectively. General instability of the nation, political disturbances, violence, terrorism etc. effects the flow of tourists.

Whatever the problems, India must work hard to reap the benefits from this industry, as the country has everything to attract visitors from far and near.

20th Sep. 20xx, situated in close proximity, to Agra, Firozabad homes to more than 1000 glass workshops, factories and industries employing more than four lakh labourers. Since decades, this small scale industry has manufactured, supplied and exported everything and anything pertaining to glass. The labourers work in miserable and unhygienic conditions. The pollution caused during manufacturing of glass products causes chronic bronchities. The workers are exposed to immense heat and sound for which they are not provided any protective eye gears which often results in accidents.

A good number of employed labourers are women and children. Women work in worse conditions. They are usually employed in factories to clear the molten glass that falls around the furnaces. The wages paid are very low and no maternity leave is given to them. Children are employed in packing and sorting work in factories. About 50,000 children below the age of 14 work in this industry. This is one of the highest concentration of child labour in the world. If child labour is eliminated, production in glass and bangle industry would go down by 25%. About 85% of the children are employed in carrying molten glass on a seven-foot rod. They sit in front of furnaces where temperature is about 700 degree centigrade. Continuous exposure to high temperature harms their health permanently. Children are forced to forgo their education and assist their parents. Over 1 lakh out of 4 lakh workers work from home but then they do not get the benefits of welfare schemes.

The pitiable state of the workers especially children working in glass factories in Firozabad should be effectively worked out.

10. (i) The author and his grandmother shared a very healthy relationship. As the author's Parents had left for town, they were constantly together making them good friends. Their relationship changed when they were called to live in the city. The author joined an English school and the grandmother was left confined in the house. The author went to university and then went abroad bringing about distance in their relationship. But then their feelings for each other did not change though distances grew between them.

(ii) Archaeology has changed substantially in the modern times. The old technology has paved the way for new ones. It now focusses less on treasures but more on other aspects of life and the mysteries of death. Modern archaeologists have all the latest tools and equipments with which they can carry on their work minutely and in detail, like scanning which has overcome the use of x-ray. In CT scan, hundreds of X-ray are put together in cross section like slices of bread to create a three dimensional virtual body. X-ray provides only a dimensional image. Thus CT scanning gives minute details and gives information of various things in depth which could otherwise not be seen with a naked eye.

The novel technique employed to tackle the spoilt children and a grown up man who is amusing and thought provoking. A submissive mother transforms herself into a bold and dominating mother and acts sternly towards her children making them realize the need of proper attention and respecting their mother. They are made to learn lessons in courtesy and polite behaviour not only towards their mother but also towards the visiting neighbours. The mother certainly has her day when the children treat with her properly and when supper was prepared by the children, their stay at home and the family game of rummy, was the rare gift that the mistress of the house received on that important day.

12. The grandmother was used to the life of the village. She got up early in the morning, she woke up her grandson and got him ready for school. She was very much concerned about the education of the narrator. She accompanied him to the school. She read scriptures while sitting in the temple. She was friendly even to the street dogs and fed them regularly in the village.

The city life and its culture did not suit her. She was a religious lady and quite conservative in her thinking. The English school, English language and Science were strange to her. She was upset to know that they didn't teach about God and scriptures at the school. She hated music which was taught in city school's as she felt music was not meant for entertainment.

The bond of friendship between the author and his grandmother broke because of distance between them and because of different thinking between them. The city life never suited grandmother and she accepted her loneliness silently.

The children faced the situation more bravely than their elders as they did not show any sign of defeat in the face of disaster. The children did not discourage their parents. They kept their spirits high by making lovely cards and not complaining of their pains and troubles. They remained strong and composed. Suzanne had a bump on her forehead and her eyes became narrow slits, yet she did not bother her daddy about her injuries as he was busy in more important tasks. Jonathan said that they were not afraid to die if they could all be together. The adults reacted with a fighting spirit. The ship was broken, but they continued their struggle to survive the disaster. Their fighting spirit, will power and optimism saved them all.

13. (a) Throughout the book Booker lays stress on education as the only means to uplift his people and enable them to lead a meaningful life. For this he knew very well that it is possible only when they (Students) will learn things practically. Booker wanted his students to be more hygienic and smart and active in all way for that he emphasised on the practical knowledge more than the bookish knowledge. He realized that mere freedom was not enough to end slavery. The question was to change the mindset of the whites who considered them fit only for manual work. He himself struggled for education as he was convinced that it was the only way to improve the blacks and this could be only possible if the students would get practical knowledge.

Booker believed that the magic wand that could bring the blacks at par with the whites was the smooth amalgamation of traditional education and manual work and labour. His idea of education coupled with academics. He quoted many examples to prove that more education could not cope with the increasing demands of the educated people. He laid stress on a new work ethic where Industrial labour was an integral part of learning.

Or

The trip to Europe was not only a time of rest for Booker, but it was also a learning experience. He brought back many new ideas from the countries he visited. He discovered that the philosophies he lived by as to the mixing of the races were already in place in Europe. This made him believe that there was hope for the American Negro.

One of the greatest surprises of his life occurred when one of the ladies at a public meeting in the interest of Tuskegee told him that they had raised sufficient funds for him and his wife to travel to Europe. The route was all mapped out and everything was already organized. Booker did not know how to take vacation. However, his wife told him he needed rest and letters of introduction had been sent to help him in the society of Europe. The trip was well planned and at every stop on the way proper arrangements had been made to make Booker's trip memorable.

(b) The Ghost's efforts of frightening the Otis family had been thwarted by the twins and Washington. He had been feeling very weak and excited for the last four weeks. He stayed in his room for five days contemplating on his strategy of terrifying the bold family. He gave up the idea of renewing the blood stains on the library floor. In his opinion the Otis family live on a low plane of existence and did not understand the symbolic value of seasons phenomena but he was much insulted by the twins and wanted to take revenge upon them. He therefore, decided to appear before them in the guise of 'Reckless Robert' or 'Headless Earl.'

So he had not appeared in this guise for the last-seventy years. But whenever he assumed this guise he got the desired result. He remembered how the frightened lady Barbara Montague had led her to break away with Lord Canterville's grand father on the ground that the Canterville allowed the ghost to move freely in their house his other attempts to frightening the Otis family also meet failure.

For example his way on the corridor was obstructed by the twins they laid a rope on his way. The Ghost did not notice it, he struck against the rope and fell down.

On the other side the Lord said that he (Mr. Otis) bought the house along with its ghost so he (Mr. Otis) should keep the jewels with him Besides, the ghost gave them to Virginia who won for him a corner in the garden of death.
